Dear Sir,

CRISIL have audited the Placement Report prepared by CMS Business School (Jain University), for the final placements of students in the MBA batch of 2015-17. CRISIL has validated the information provided in the report with the relevant documentation, and offers the following comments:

1. CRISIL have obtained all information and explanations as were necessary for conducting the audit. We believe the Placement Report complies with the requirements of Indian Placement Reporting Standards (IPRS) Version 2.1.
2. The validation of information presented in the report is based on communication received by CMS Business School from the recruiting companies. CRISIL has not independently sourced any information or documentation.
3. CRISIL have verified the information with respect to remuneration, job function and location presented in the report with communication received from recruiters. Information regarding compensation received from individual students has not been used.
 - a. Out of 325 students in the batch, 201 students were eligible for placement from which 60 did not seek placement through institute and 3 remained unplaced. Offer letters of remaining 138 students were verified.
 - b. The information has been categorized as best as possible under various salary heads according to IPRS Version 2.1; where a break-up was not available, the salary has been considered only as 'Maximum earning potential'.
 - c. Proof of acceptance of the offers is indicated by student signing the offer letter. Such proof was not available for 114 students.


